All chairs were asked to send emails to their directors with information about the zoom meetings, audition procedures, and any other information they might need.

The audition fees for this year will be the same as in past years, \$8 per audition for all HS honor groups. There will be no participation fees for any SCKMEA honor ensemble since there will be no ensemble performances this year.

This year, the state has relaxed their requirement for students to participate in their local school's music programs in order to participate in All-State groups. Due to the schedules imposed on schools because of the Corona Virus, eligibility will be handled by each district individually. If our district considers a student eligible, so will the state. If a school only offers a performing ensemble class for one 9-weeks period, and a student participates in that, they will be considered eligible.
